RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FONTANA, CALIFORNIA, AUTHORIZING THE DONATION OF COMPUTER EQUIPMENT TO THE AFFORDABLE HOUSING - PASEO VERDE APARTMENTS COMMUNITY COMPUTER LAB

- WHEREAS, the City of Fontana Information Technology Department has identified ten (10) desktop computers and ten (10) monitors that have exceeded their useful life in the City's computing environment; and
- WHEREAS, absent this action, the equipment would be disposed of through surplus auction; and
- **WHEREAS,** the City desires to support digital inclusion and access to educational, employment, and essential online services for residents of the Affordable Housing Paseo Verde Apartments; and
- **WHEREAS**, the donation of the equipment provides a greater public benefit than auctioning such items; and
- **WHEREAS**, the recipient will assume all responsibility for installation, maintenance, licensing, connectivity, and ongoing support and the City will have no further obligations after transfer.
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Fontana, California, as follows: the City Council of the City of Fontana hereby authorizes the donation of ten (10) desktop computers and ten (10) monitors to the community computer lab at the Affordable Housing Paseo Verde Apartments and authorizes the City Manager or designee to execute all documents necessary to effectuate the donation.
- **Section 1.** Recitals. The above recitals are true, correct and by this reference incorporated herein.
- <u>Section 2.</u> <u>Findings/ Approvals.</u> City Council hereby approved the donation of 10 desktop computers and 10 monitors to be used in the Paseo Verde Apartments center computer lab.
- <u>Section 3.</u> <u>Effective Date</u>. This resolution shall become effective immediately upon approval by the City Council.
- <u>Section 4.</u> <u>Severability.</u> If any provision of this Resolution or the application of any such provision to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid provision or application, and to this end the provisions of this Resolution are severable. The City Council declares that it would have adopted this Resolution irrespective of the invalidity of any particular portion of this Resolution.
