


BOUNDARY ESTABLISHMENT NARRATIVE:

OUR INVESTIGATION INTO THE ESTABLISHMENT OF THE EXISTING BOUNDARY OF THE PROPERTY SUBDIVIDED BY THIS MAP, AND THE ADJACENT LYTHE CREEK ROAD ALIGNMENT LED TO A MONTHS-LONG INVESTIGATION INTO THE HISTORY OF THE SURVEYING AND BOUNDARY LINES IN THE AREA, IN ORDER TO DETERMINE THE MOST LIKELY LOCATION OF THE LINE BETWEEN LOTS 19 AND 20 OF "MAP SHOWING SUBDIVISION OF LANDS BELONGING TO THE SEMI-TROPIC LAND AND WATER COMPANY" SURVEYED IN AUGUST 1887, RECORDED IN MAP BOOK 6, PAGE 12, RECORDS OF SAN BERNARDINO COUNTY. THIS INVESTIGATION RESULTED IN RESEARCH INTO SOURCES NOT NORMALLY AVAILABLE TO OR ACCESSED BY PRIVATE SURVEYORS. THESE INCLUDED INTERNAL LOS ANGELES DEPARTMENT OF WATER AND POWER FIELD NOTES, SOUTHERN CALIFORNIA EDISON INTERNAL MAPPING, AND SAN BERNARDINO COUNTY SURVEY RECORDS NOT AVAILABLE ON THE RESEARCH WEBSITE.

DURING THE COURSE OF THIS INVESTIGATION, IT BECAME CLEAR THAT WHILE THE MAP DEPICTS THE SOUTHWESTERLY LINE OF THE SUBDIVISION TO BE COINCIDENT WITH THE SOUTHWESTERLY LINE OF THE RANCHO MUSCUPIA, IN ACTUALITY THE PORTION OF THE SUBDIVISION LINE IN THE VICINITY OF THIS MAP WAS MONUMENTED ALONG A LINE ROUGHLY 35' NORTHEASTERLY OF THE RANCHO LINE. SINCE THE LINE AS MONUMENTED FALLS INSIDE THE RANCHO, A GAP WAS THEREBY INADVERTENTLY CREATED.

ACCORDING TO PENCIL NOTES ON COUNTY SURVEYOR MAP C.S. 1350, IN 1932 EDGAR T. HAM, LS 730, RETRACED A PORTION OF RIVERSIDE AVENUE AND THE SOUTHWESTERLY LOT LINES IN THIS AREA, FINDING VARIOUS MONUMENTS OF CURRENTLY UNKNOWN ORIGIN, BUT APPARENTLY ACCEPTED AS DEFINING THE LINES AND CORNERS OF THE SUBDIVISION AT THE TIME. DURING HIS CAREER MR. HAM PERFORMED SURVEYS IN BOTH PRIVATE PRACTICE AND AS SAN BERNARDINO COUNTY SURVEYOR. IT APPEARS HE PERFORMED THE WORK RELEVANT TO THIS MAP AFTER HIS TERM AS COUNTY SURVEYOR HAD ENDED. THE PENCIL NOTES ON C.S. 1350 INDICATE THAT HE FOUND MONUMENTS AT THE SOUTHERLY CORNERS OF LOTS 33/35, 23/25, 22/23 AND 21/22. HE THEN EXTENDED THE LINE FORMED BY THESE MONUMENTS NORTHWESTERLY BEYOND A STONE MOUND FOUND AT THE COMMON CORNER OF LOTS 21 AND 22, USING RECORD DISTANCES PER THE MAP, AND SET AN AXLE AT THE CENTERLINE OF THE 60' RIGHT OF WAY BETWEEN LOTS 19 AND 20, AS WELL AS AT THE WESTERLY CORNER OF LOT 19. (ACCORDING TO THE PENCIL NOTATIONS, THERE APPEARS TO HAVE BEEN A MISCALCULATION OF EXACTLY ONE LINK IN THE RECORD DISTANCE ALONG THE SOUTHWESTERLY LINE OF LOT 19: 629.64' = 9.54 CHAINS, VS. 9.55 CHAINS PER THE MAP.)

THE PENCIL NOTES ALSO INDICATE THAT MR. HAM SIMULTANEOUSLY TIED INTO MONUMENTS SET BY GOVERNMENT SURVEYOR LEWIS H. CUTTING IN 1896 TO MARK THE RANCHO CORNER AND THE CLOSING CORNER OF THE LINE BETWEEN SECTIONS 7 AND 18 ON THE RANCHO LINE. THE RANCHO CORNER IS DESIGNATED "M-42" ON VARIOUS GOVERNMENT SURVEYS PERFORMED IN THE LATE 1800'S AS WELL AS ON M.B. 6/12. IN 1896 MR. CUTTING PERFORMED A SURVEY OF THE SAN BERNARDINO FOREST RESERVE UNDER CONTRACT WITH THE UNITED STATES GOVERNMENT. DURING THE COURSE OF HIS SURVEY HE FOUND AND REPLACED THE ORIGINAL M-42 CORNER MARKER WITH A 4X4 CAST IRON MONUMENT FILLED WITH CONCRETE AND PRE-STAMPED WITH APPROPRIATE MARKINGS. HE ALSO SIMILARLY FOUND AND REPLACED THE CLOSING CORNER MONUMENT OF THE LINE BETWEEN SECTIONS 7 AND 18 WITH THE RANCHO LINE, ORIGINALLY SET BY GOVERNMENT SURVEYOR JOHN GOLDSWORTHY IN 1874. THE NEW MONUMENTS WERE MARKED AND REFERRED TO AS SBFR-61 AND SBFR-62, RESPECTIVELY.

THE PENCIL NOTES ON C.S. 1350 SHOW THESE MONUMENTS WESTERLY OF THE SUBDIVISION LINE AS DEFINED BY THE FOUND MONUMENTS PREVIOUSLY DESCRIBED, AND AS PROJECTED NORTHWESTERLY BY MR. HAM. HOWEVER IN 1929 MR. HAM HAD ALSO PERFORMED A SURVEY OF LOTS 2, 3, 4, 5, 6, 11 AND 19 OF THE SUBDIVISION (R.S. 2/20) IN WHICH HE FOUND AND ACCEPTED THE 4X4 IRON MONUMENTS AS REPRESENTING THE CORNER OF LOT 19 AND A POINT ALONG ITS SOUTHERLY LINE. COUNTY SURVEYOR MAPS CS-319 (1922) AND CS-406 (1925) ALSO SHOW THESE MONUMENTS AS REPRESENTING THESE LOCATIONS. IT IS NOT CLEAR WHY MR. HAM DID NOT ACCEPT THE ORIGINAL GOVERNMENT MONUMENTS IN 1932 WHEN HE HAD ACCEPTED THEM THREE YEARS EARLIER, EXCEPT PERHAPS FOR THE SOMEWHAT DISTASTEFUL PROSPECT OF ANGLING THE SUBDIVISION LINE. BUT BY EXTENDING THE LINE PAST SURVEY MONUMENTS INSTEAD OF WORKING BETWEEN THEM, THE AXLES HE SET TO REPRESENT THE CORNER OF LOTS 19 AND 20, AS WELL AS THE WESTERLY CORNER OF LOT 19, WERE NOT SET IN ACCORDANCE WITH STANDARD SURVEY PRACTICE.

BECAUSE OF THE CONFUSION CREATED BY THE TWO SETS OF MONUMENTS, AND BECAUSE THE 4X4 IRON POSTS WERE LATER DESTROYED AND THE LINE DEFINED BY THE AXLES PERPETUATED, PROBLEMS ARISE WITH INTERPRETING DEED DESCRIPTIONS THAT WERE WRITTEN BASED ON THE ORIGINAL GOVERNMENT CORNERS, INCLUDING THE VESTING DEEDS FOR THE PROPERTIES EACH SIDE OF THE LINE BETWEEN LOTS 19 AND 20, AS WELL AS THE DESCRIPTIONS OF LYTHE CREEK ROAD. THIS RESULTED IN AN APPARENT OVERLAP CREATED BY THE DEEDS FOR THE PROPERTIES EITHER SIDE OF THE LINE BETWEEN LOTS 19 AND 20 OF M.B. 6/12. FURTHER CONTRIBUTING TO THE CONFUSION WAS THE WORDING IN THESE DEEDS, WHICH REFER TO "THE EASTERN LINE OF LOT 19." IT APPEARS THIS WAS VARIOUSLY INTERPRETED TO REFER TO THE NORTHWESTERLY RIGHT OF WAY LINE OF THE 60' RIGHT OF WAY, AND TO THE CENTERLINE OF THAT RIGHT OF WAY. FROM A CLOSE INSPECTION OF THE DISTANCES SHOWN ON M.B. 6/12, IT BECOMES CLEAR THAT THE DISTANCES THEREON ARE TO THE STREET CENTERLINES, NOT TO THE RIGHT OF WAY LINES, AS WOULD TODAY BE SHOWN. IN PERFORMING THIS SURVEY, WE HAVE ACCEPTED THE INTERPRETATION OF DEED CALLS TO THE LOT LINES TO BE TO THE CENTERLINE OF THE 60-FOOT RIGHT OF WAY, AND NOT TO ITS SIDELINES.

IN FORMULATING MY FINAL OPINION AS TO THE LOCATION OF THE BOUNDARY LINE BETWEEN LOTS 19 AND 20, AND HENCE THE CENTERLINE OF THE 60' RIGHT OF WAY WHOSE CENTERLINE IS REPRESENTED BY THAT LINE, I HAVE PROPOSED THAT THE SUBDIVISION LINE AS PERPETUATED BY VARIOUS SURVEYS IN THE AREA IS NOT THE SAME LINE AS THE RANCHO LINE, AND THAT THERE IS A GAP BETWEEN THE TWO IN THIS AREA. THE EFFECT OF THIS DIFFERENCE IN LOCATION BETWEEN THE SUBDIVISION AND RANCHO LINES ON OTHER PROPERTIES SOUTHEASTERLY ALONG THE RANCHO LINE FROM THE SUBJECT PROPERTY OF THIS MAP, AND ANY ATTEMPTED RESOLUTION OF THAT DIFFERENCE, IS BEYOND THE SCOPE OF THIS SURVEY.

BECAUSE THE LINE BETWEEN MONUMENTS SBFR-61 AND -62 WAS ACCEPTED AS THE SOUTHWESTERLY LINE OF LOT 19 BEFORE MR. HAM'S SURVEY WORK IN 1932 WITH NUMEROUS DEED DESCRIPTIONS HAVING BEEN WRITTEN BASED ON THIS ASSUMPTION (INCLUDING R5 & R7), I HAVE ACCEPTED THE RANCHO LINE AS DEFINING THE SOUTHWESTERLY LINE OF LOT 19. ALSO, SINCE MONUMENT SBFR-62 WAS NEVER PROVEN TO FALL ON THE RANCHO LINE AFTER ITS INITIAL PLACEMENT, AND SINCE IT ACTUALLY APPEARS TO HAVE FALLEN SOUTHWESTERLY OF THE RANCHO LINE, I HAVE USED ITS POSITION ONLY AS A POINT OF REFERENCE TO DETERMINE THE BEGINNING POINTS OF DEED DESCRIPTIONS FOR THE PROPERTIES EACH SIDE OF THE LINE SEPARATING LOTS 19 AND 20, AS WELL AS FOR THOSE DEED DESCRIPTIONS CREATING THE LYTHE CREEK ROAD RIGHT OF WAY. I ALSO USED ITS POSITION TO CALCULATE THE LOCATION OF THE COMMON QUARTER CORNER OF SECTIONS 7 AND 18.




