A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FONTANA ACCEPTING THE PROPOSED DISTRIBUTION OF AD VALOREM TAXES AS REQUESTED BY THE SAN BERNARDINO COUNTY AUDITOR-CONTROLLER'S OFFICE FOR LAFCO 3261 WHICH IS FOR THE REORGANIZATION AND ANNEXATION TO THE CITY OF FONTANA AND DETACHMENT FROM COUNTY SERVICE AREA 70 FOR APN 0239-072-02 (DEBRIS BASIN FOR I-15 LOGISTICS PROJECT).

<u>SECTION 1.</u> The City Council, as governing body of the City of Fontana, finds and determines that:

- (A) Pursuant to Section 99 of the Revenue and Taxation Code, the governing bodies of all local agencies whose service area or service responsibilities will be altered by a proposed jurisdictional change shall negotiate and determine by resolution the amount of property tax revenues to be exchanged between and among such local agencies.
- (B) Except as provide in Section 99.1 of the Revenue and Taxation Code, in the event that a jurisdictional change would affect the service area or service responsibility of one or more special districts, the Board of Supervisors of the County of San Bernardino shall, on behalf of the district or districts, negotiate any exchange or property tax revenues.
- (C) The City Council of the City of Fontana and the Board of Supervisors of the County of San Bernardino have determined the amount of property tax revenues to be exchanged as a result of the following jurisdictional change (Exhibit A attached):

LAFCO 3261 - REORGANIZATION TO INCLUDE ANNEXATION TO THE CITY OF FONTANA AND DETACHMENT FROM COUNTY SERVICE AREA 70 FOR APN 0239-072-02 (DEBRIS BASIN FOR I-15 LOGISTICS PROJECT)

<u>SECTION 2</u>. The City Council of the City of Fontana herby resolves and orders that:

(A) The negotiated exchange of property tax revenues between the City of Fontana, County Service Area 70 and the County of San Bernardino, yields \$193.00 resulting from the above-described jurisdictional change, is approved and accepted.

(B) The annual tax increment generated in the areas subject to the jurisdictional change and attributable to the local agencies whose serve area or service responsibilities will be altered by the proposed jurisdictional change shall be allocated in future years pursuant to the provision of Section 98 of the Revenue and Taxation Code.

<u>SECTION 3.</u> The City Clerk of the City of Fontana is hereby directed to certify passage of this resolution and to cause a certified copy to be sent to the Executive Officer of the Local Agency Formation Commission for San Bernardino County.
