## Standard Vehicle Integration w/lights and sirens (201570-004)

The Standard Vehicle Integration w/lights and sirens is only available for the 2006 – Present Chevrolet Tahoe or Suburban (other types of vehicles may require a surcharge), 5.3 liter V8, with LT model trim package or above, and second row bucket seats for laptop hardware mounting. For all installations, customer is responsible for vehicle transport to and from Jacobs facility in Severn, Maryland.

- Jacobs will tint windows.
  - o 35% driver and passenger side windows
  - o 5% all other windows
  - o No tint on windshield
- Jacobs will install emergency lights and siren throughout the vehicle
  - o Fenix Cannon 120 and 360 LEDs in the forward and rear lamp compartments (head/tail/fog)
  - o Whelen ION DUO and TRIO flashers in grill and rear bumper
  - o Whelen Alpha 12 Siren
- Jacobs will design and install an independent, auxiliary power system for support of Base Station NG to include:
  - o 270 Amp Dual Alternator
  - o 2x Marine-grade AGM Battery
  - o Cabling, Fuses & Circuit Breakers
  - o Pure Sine Wave Inverter/Charger
  - o Rack-mount Power Distribution Bus
  - o AC Power Strip and Shore power
  - o Ammeter and Voltmeters for system power monitoring in cargo area
  - o Crossover switch and relay to allow vehicle ignition from supplemental battery
  - o Remote power switches in the front overhead driver area
  - o Low Voltage Drop Out (LVDO) to prevent battery and equipment damage
- Installation of wireless broadband router (CradlePoint IBR900 Dual SIM or equivalent) to allow in-vehicle network, wireless and cellular data network connectivity (customer responsible for cellular carrier service).
- Jacobs will install a customer purchased Base Station NG system, and associated purchased accessories, to include:
  - o Dual 19" open equipment racks and shelving to accommodate the Base Station NG system and its subordinate amplifiers.
  - o GPS antenna installation (USB style feed)

    - Installation of the TRACHEA2+ DF system antenna modules
    - Integration of display into vehicle navigation system serves as a second Windows monitor (when possible)
- Choice of front or rear prewired hard mounts for laptop to allow system control in either the front and rear operator position
  - o Installation and configuration of system controller [Dell Laptop] (if purchased as an accessory)
  - o Each operator position will also have USB drops to allow charging and programming of handheld RF devices
  - o Rear cargo area LED work lights
  - o Front passenger area will have Ethernet drop for wired connectivity to the vehicle network
