Master Case (MCN) No. 23-0104: Tentative Parcel Map No. 20664 (TPM No. 23-0017)/Design Review (DRP) No. 23-0027

A request to consolidate five (5) parcels into one parcel along with the site and architectural review of an industrial commerce center facility totaling approximately 166,985 square feet on approximately 9.19 adjusted gross acres.

Environmental Determination:

Pursuant to Sections 15162 and 15164 of the California Environmental Quality Act (CEQA) Guidelines and Section 8.06 of the City of Fontana's 2019 Local CEQA Guidelines an Addendum to the Southwest Industrial Park Specific Plan Program Environmental Impact Report (SWIP PEIR) (State Clearinghouse [SCH] No. 2009091089) has been prepared for this proposed project. The aforementioned EIR was adopted by the City Council on June 12, 2012, and it anticipated the development of a warehouse building and also adequately identified any potential impacts associated with this project.
