A PUBLIC HEARING HAS BEEN SCHEDULED BEFORE THE CITY COUNCIL OF THE CITY OF FONTANA FOR THE FOLLOWING:

Appeal (APL) No. 25-0001/ Master Case No. 22-00104

A request by Golden State Environmental Justice Alliance ("The Appellant) to appeal the Planning Commission's decision on June 3, 2025, which approved Master Case No. 22-0104 for Tentative Parcel Map No. 22-0025 (TPM No. 20611) and Design Review No. 22-0051 along with the certification of an Final Environmental Report (FEIR) State Clearinghouse Number (SCH No. 2023030788), Monitoring, and Reporting Program, (MMRP) to facilitate the consolidation of six (6) parcels into one parcel, vacation of Windflower Avenue and the development of an industrial warehouse building totaling approximately 398,514 square feet on approximately 18.3 acres (APNs: 1119-241-10, -13, -18, -25, -26, and -27).

Environmental Determination:

On June 3, 2025, the Planning Commission certified a Final Environmental Impact Report (FEIR) that analyzed potential environmental impacts associated with the development of the property for Master Case No. 22-000104: Tentative Parcel Map No. 22-0025 (TPM No. 20611) and Design Review No. 22-0051 in accordance with the California Environmental Quality Act Guidelines. 
